10. New Business - Superintendent

A. Strategic Plan and Enhancing Student Learning Coherence Cycle

The Strategic Plan Monitoring Cycle is monitored through <u>Continuous Learning Reports</u> that are aligned to the Strategic Priorities. This helps monitor continuous improvement in student learning outcomes in the district. Superintendent Smillie outlined how data helps to monitor student learning improvements, helps schools to create learning environments for students and help the district make strategic decisions as well as plan professional development for staff.

B. Partner Engagement on Literacy, Numeracy, Online Learning, and Connected Learning

In an interactive session, attendees were invited to analyze data coming from the reports and review the alignment to the Strategic Priorities and whether any adjustments were required. Attendees were assigned in groups to review data and discuss future action on

- Connected Learners Continuous Learning
- Online Learning Continuous Learning
- Numeracy Continuous Learning
- Literacy Continuous Learning

Questions and suggested action items were recorded at each station and will be incorporated in future annual reporting cycles. District Leaders shared common themes and highlighted key discussion items with the group. Committee members were provided with an opportunity to add further questions and comments.

Superintendent Smillie concluded the agenda item with an outlook on four more reports and more opportunities to interact with data and give feedback in the 2023-2024 school year. Feedback received will be incorporated in future annual cycles.

C. Partner Group Discussion

One partner group representative suggested adding an opportunity for partners to share comments and questions as a standing agenda item for this committee.

The committee member shared items which were determined to be of operational nature and were referred to a labour management meeting.
